

SELLING THE CHOMETZ - EAYC

Since it is prohibited to possess chometz on Pesach, we either dispose of it or sell it to a non-Jew before Pesach begins. This includes all chometz that will not be eaten or burned before Pesach and all chometz utensils that will not be thoroughly cleaned by then. These are stored away in sealed closets, rooms and cupboards while preparing for Pesach. These storage areas, closets, rooms or cupboards must be locked or taped closed and specifically marked, and these areas are leased to the non-Jew at the time of the sale of Chometz and the items sold to him.

Please note: All chometz which remains in the possession of a Jew over Pesach - may not be used, eaten, bought or sold even after Pesach.

Business premises must also be listed and any chometz therein should be sold to the non-Jew and may not be used or sold on Pesach.

Women, who have their own properties or offices, which may contain chometz, must complete their own form or come themselves to sign the original document or explicitly ask their spouses to add their names and details to it. They should not rely on their spouses' signature, unless they specifically delegate him to sign on their behalf.

The document below or the online form should only be used if you cannot come in person and sign the original document.

DELEGATION OF POWER OF ATTORNEY FOR SALE OF CHOMETZ

I, the undersigned, fully empower and authorise Rabbi Zvi Hirsh Lieberman to act in my place and stead and on my behalf to sell all Chometz possessed by me, knowingly or unknowingly as defined by the Torah and Rabbinical Law (e.g. chometz, possible Chometz, and all kinds of Chometz mixtures). Also Chometz that tends to harden and adhere to inside surfaces of pans, pots, or cooking utensils, the utensils themselves, and all kinds of live animals and pets that have been eating Chometz and mixtures thereof. I also authorise Rabbi Zvi Hirsh Lieberman to purchase the Chomtez on my behalf when halachically permitted to do so.

Rabbi Zvi Hirsh Lieberman is also empowered and authorised to lease on my behalf all places wherein the Chometz owned by me may be found, at the address/es listed below, and anywhere else. Rabbi Zvi Hirsh Lieberman is also empowered to act on behalf of all those who have asked me to arrange for the sale of Chometz on their behalf. Rabbi Zvi Hirsh Lieberman has full right to appoint any agent or substitute in his stead and the substitute shall have full right to sell and lease as provided herein. Rabbi Zvi Hirsh Lieberman also has the full power and right to act as he deems fit and proper in accordance with all the details in the Bill of Sale used in the transaction to sell all my Chometz, Chometz mixtures, etc., as provided therein and in the power of authority document in Rabbi Zvi H Lieberman's possession and as Rabbi Zvi H Lieberman sees fit. This authorisation is made a part of the Bill of Sale.

This power is granted in conformity with all Torah, Rabbinical and Civil laws.

My signature below empowers Rabbi Zvi H Lieberman to act as my delegated authority to sell all my Chometz and to lease all the properties where it is found and constitutes a formal kinyan.
